

NORTHPOWER FIBRE UFB PRICE CAPS

As at 1 July 2020. Version 1.1

This document, published and maintained by Crown Fibre Holdings Limited (CFH), sets out the Price Caps for Services offered by Whangarei Local Fibre Company Limited (Northpower Fibre) under its UFB Reference Offer. The Price Cap for a Service may not be the same as the Charge for that Service (although the Charges cannot exceed the Price Caps). Not all Services are subject to Price Caps. Please refer to the Northpower Fibre Reference Offer, available at <http://northpowerfibre.co.nz/index.php/agreements>, for a more detailed description of the Services listed below.
